

(15) Description of equipment

The CombiView is a display intended for displaying data from several types of transmitters.

It has a touch sensitive screen for interaction with the user.

It receives data and power from either 4-20 mA loop, or direct communication with the transmitter. The PCB is mounted in a circular molded plastic housing. It is designed to fit in a Ø80 housing. Input and power is either provided through 2 wires in a 4-20 mA current loop, or through the communications cable to the attached transmitter.

The CombiView DFON must be supplied through a zener barrier to make the display intrinsically safe. The transmitter may be placed inside or outside the hazardous area as preferred. If relay option is enabled, each relay connection must be intrinsically safe secured by zener barriers.

- (17) Special conditions for safe use
- 1. This product is allowed to be operated in an explosion hazardous atmosphere of zone 0 only if atmospheric conditions exist (Temperature from -20°C to 60°C, pressure from 0,8 bar to 1,1 bar). Under other than atmospheric conditions, the certificate may be used as a guide.
- 2. Impact test of the display is done to EN 60 079-0, with low impact energy of 2J. The housing, connecters and cable glands are impact tested with the low energy of 4J.
- 3. This product contains no replaceable parts. In case of malfunction the product must be shipped to Baumer for repair.
- 4. Use of FlexProgrammer 9701 is only allowed in the safe area.
